



LIMITED ONE-YEAR WARRANTY WASHER/DRYER

THE SELLER NAMED BELOW MAKES THE FOLLOWING WARRANTY WITH RESPECT TO THE DOMETIC WASHER/DRYER PRODUCT:

1. This Limited Warranty is made by Dometic (the "Seller") only to the first purchaser (hereinafter referred to as the "Original Purchaser") who acquires the Product for Original Purchaser's personal use and then only when the Product is installed in a vehicle built to current edition R.V.I.A. A119-2 or C.R.V.A. Z-240 standards, and only when operated within the continental United States or Canada.
2. This Limited Warranty will be in effect for one (1) year from the date of purchase of the Product by the Original Purchaser. The Original Purchaser needs to provide sufficient documentation to validate the Limited Warranty such as a copy of the vehicle bill of sale if the Product purchased as a component of a vehicle, or the sales receipt if purchased separate from the vehicle.
3. This warranty does not cover conditions unrelated to the material and workmanship of the Product. Such unrelated conditions include, but are not limited to: (a) damage not reported within 7 days of ownership; (b) failure or damage caused by lightning or high voltage; (c) faulty installation and any damage resulting from such; (d) the need for normal maintenance and any damage resulting from the failure to provide such maintenance; (e) failure to follow the Sellers instructions for this Product; (f) any accident to, or misuse of any part of this product and any alteration by anyone other than the Seller or its authorized representative; (g) damage or failure caused by the installation of accessories not manufactured and marketed by the Seller; and (h) normal wear and product abuse.
4. In order to obtain the benefits of this Limited Warranty, return the Product to the Seller's authorized service center during the period that this warranty is in effect. The Original Purchaser must pay all charges incurred in delivery of the Product to and return of the Product from the Seller's authorized service center. The dated proof of purchase must accompany the returned Product.
5. The Seller or its authorized service center will examine any Product returned in the manner described in paragraph 4. If it is found that the returned Product is defective in material or workmanship, the Seller will repair it or replace it with new product which is substantially similar to the original Product without charge for material or labor, alternatively the Seller, at its sole option, may choose to refund the purchase price of the product in the amount equal to Seller's current retail price of same. **The Original Purchaser shall not pay a Service Agency for Warranty repairs. Such payments will not be reimbursed.**
6. The Seller does not authorize any person or company to create any warranty obligations or liability on its behalf. This Limited Warranty is not extended by the length of time which you are deprived of the use of the Product. Repairs and replacement parts or complete Product provided under the terms of this warranty shall be limited to the non-expired portion of this warranty.
7. REPAIR OR REPLACEMENT OF, OR REFUND FOR, DEFECTIVE PRODUCT, AT SELLER'S OPTION, SHALL BE THE ORIGINAL PURCHASER'S SOLE REMEDY UNDER THIS LIMITED WARRANTY. In no event shall Seller be liable for incidental or consequential damages. This includes any damage to another product or products resulting from a defect. Some states do not allow the exclusion of incidental or consequential damages, so the limitations may not apply.
8. SELLER DISCLAIMS ALL OTHER WARRANTIES WITH RESPECT TO THE PRODUCT, WHETHER EXPRESS OR IMPLIED, AND SPECIFICALLY DISCLAIMS THE IMPLIED WARRANTIES OF MERCHANTABILITY AND FITNESS FOR A PARTICULAR PURPOSE. Some states do not allow limitations on how long an implied warranty can last, so the above limitation may not apply.
9. THIS LIMITED WARRANTY GIVES SPECIFIC LEGAL RIGHTS, YOU MAY ALSO HAVE OTHER RIGHTS WHICH VARY FROM STATE TO STATE. No action to enforce this warranty shall be commenced later than ninety (90) days after the expiration of the Limited Warranty period. Claims must be submitted in writing to the Dometic Warranty Department for arbitration.
10. The Seller reserves the right to change the design of any Product without notice and with no obligation to make corresponding changes in Products previously manufactured.
